In his fiction, Ghosh has actually analyzed the inability of the present generation to understand the range and the physical damage of climate change and assumes that this is reflected in our time's literary works, in the recording of background and also in the political environment of our day

River of Smoke entirely deals with the breakout of the opium war (1839- 42). After ruining the Indian landscape and looting its capital, the British promote Industrial Revolution and the expansion of the empire. They convert Indian land into the producer of raw materials whose access is confined exclusively to English factories. Mishra quotes Fairbank, —In 1830, the auditor-general of the East India Company declared that every year at least £4,000,000 had to be carried back from India to England (71). The cultivation of poppy flowers and the processing of seeds into opium in India and its sale in China by British, American and Indian traders is the most spotlighted aspect of the novel. Imperialists and colonizers are greatly responsible for death and destruction of native flora, fauna, cultures and human beings of the annexed bio-regions. The novel tracks down the instances.

River of Smoke unfolds the ecological consciousness through two individuals who undertake a journey to Canton in a botanical ship the Redruth: Paulette and Penrose. Bengal born Paulette is the daughter of Pierre Lambert. He worked as a Botanist in Calcutta. After her father sdeath in Calcutta she decides to travel to Mauritius in search of her earlier family connections. She reaches to Port Louis on the Ibis along with other girmitiyas. There she takes shelter in the Pimple-mouse Botanical Gardens to be discovered by Fitcher Penrose. He is on an expedition eastwards in his own two-masted brig, the Redruth. Ghosh weaves these narratives together.

A deep ecological concern marks the narration of Honam episode. Honam is an island situated on the banks of Pearl River opposite to the city of Canton. In contrast to Canton which is crowded with houses, walls and narrow streets, "Honam is like a vast park, green and wooded: several small creeks and streams cut through it and their shores are dotted with monasteries, nurseries, orchids, pagodas and picturesque little villages" (279). This geographically diverse island becomes one of the principal settings in the novel. The country retreat of Punhyqua, the Cantonese local opium trader, is located on it. Punhyqua had deep connections with the merchants of Bombay.

Postmodern fiction plays a crucial role in transmitting ecological values. Ghosh's narrative details the invaluable exotic plants of China. From the earliest plant-hunter, James Cuninghame who belonged to the eighteenth century to the most recent, they aroused curiosity and interest.

River of Smoke invites an ecologically informed reading. Similar to Historiographic metafiction that mixes "the reflexively fictional with the verifiably historical" (Hutcheon, Politics 36), the ecological fiction is also concerned with both imaginative and natural worlds. Ghosh very clearly shows how imperialists and colonizers bring death and destruction of native flora, fauna, cultures and human beings. Britain and other foreign countries are presented in a race to accelerate their efforts to obtain China's most valuable trees and plants. Ghosh writes, —The value of China's plants had not been lost on Britain's rivals and enemies across the channel: the major physick gardens and herbariums of both Holand and France had also been endeavouring to assemble collections of China's floral (101). In a way they bring about massacre of land and its varied species for their own profit and greed. The mindless pursue and human greed of Britishers towards different species of flora of China disappears some plant species completely. It is a disgusting fact that humans are mindlessly destroying the plants and trees for their own use. A similar fact is mentioned in the novel showing how a rich botanical variety of China- Camellia sinesis disappears completely from the earth. This species of camellia from which tea is extracted is taken in possession by the foreigners and then mindlessly used as it accounts for an enormous proportion of the world's trade.

Ghosh through the novel makes a call for the paradigm shift from the anthropocentric to the ecocentric set of values. Through the fictionalized characters like Paulette, Commissioner Lin, King Charles, Ah Fay and Robin Chinnery he presents myriads of deep ecological, social ecological and ethic illumination and thoughts in pursuit of the ecological balance between nature and society, and even within human beings themselves. The social ecological wisdom as adopted by Ghosh, urges readers to respect, protect and care for other humans as well as nature. It is the need of the time to reconsider the relationships within human

Ghosh tries to highlight ecofriendly use of colours and materials used by Deeti in her paintings. Her knowledge of Madhubani painting by using rice for whitening the wall and using fruits and soil as colours, she paints beautifully but when she is stopped by her in-laws in India from painting she uses rags for painting. Her shrine is painted with pictures shows the skill possessed by the indentured labours.

The novel deals with the incidents leading to break out of Opium War (1839-42). The low demand of European commodities in China results in outpouring of silver from Britain and it leads to opium trade. Free trade is the excuse given by the English to take advantage in the opium trade. It is shown in the open letter written by the commissioner to Queen Victoria earlier it was a luxury of the upper class later it becomes an addiction leading to death and exploitation of the land and people. It is ironical that the British banned opium in their own country due to its harmful effects but talked of free trade of opium in China.

It is as peculiar as divine providence that while China suffered from the opium crisis instigated by European traders and colonisers, its blossoms delighted the very officials and soldiers advancing towards devastation. Although China may have endured setbacks against the formidable British military strategies, it undeniably contributed significantly to the advancement of human civilisation through its gifts and blessings. River of Smoke illuminates the manipulative and exploitative colonial practices of the West towards the East, while also heightening our awareness of our inherent goodness and the enduring fragrance of mankind that we will disseminate via our care for nature. Ghosh, in numerous respects, expands the function of nature beyond merely serving as a 'moral barometer'; he instead heightens our awareness of our actions. He prompts us to consider the implications of coexisting with the earth rather than merely existing upon it.

Throughout his environmentally-critical writings, Ghosh discusses the challenges facing mankind during the latest era of geological time in which people contribute to the conservation and survival of the earth. Being old, he is unable to take to any other trade and is forced to migrate to city with his wife and they turn to beggary!

Exotic details of nature -- of flora and fauna and lush vegetation -- at the foot of the Kanchenjunga present a veritable feast for the nature lovers. Even the solitude of the inhabitants of Cho Oyu has been described in terms of the giant squid spotted there on rare occasions: "No human had ever seen an adult giant squid alive, and though they had eyes as big as apples to scope the dark of the ocean, theirs was a solitude so profound they might never encounter another of their tribe" (2). The symbolic significance of the animal world is, of course, found in countless narratives produced in all times and climes. What stands out is the co-existence of the human and the animal world in that section of the Cho Oyu that is governed by the
